fastening system: by means of laces and a strap with hook and loop fastener on the collar zone;

processing: Ago;

outsole: black rubber with logo in white on the tip and marked "ALPINESTARS" in white in the heel zone with black PU midsole in the heel area;

upper: black coated microfiber DE7 declared 1.5 mm (PY-2085) matched with a double layer of 0.6 mm Twill (PY-555);

insert on the medial quarter: black coated microfiber C10 declared 1.5 mm (PY-2023) matched with a double layer of 0.6 mm Twill (PY-555);

insert on the lateral quarter: black mesh + perforated felt "1.8 JOURNEY + VELASTIFF KS 400 GEYDWR C& GTX PERFORATED" (PY-366) partially coated with black PU +PRINT+HF "0.5MM V\$705 RP P391WM\$" (PY-2086) with orange graphics and <mark>marked</mark> "WATERPROOF";

lower and higher collar: black microfiber DE7 declared 1.2mm (PY-2082) matched with white foam material, declared thickness 6.0 mm (PY-419) and a black coated fabric, declared thickness 0.5 mm (PY-230) and black three -dimensional fabric (PY-364);

vamp and quarter lining: black fabric matched with grey foam, white membrane and white jersey "N155 + 3MM K330 + COLVERA + 8126C TRICOT (36g)" (PY-351);

collar evelet lining: black coated knit fabric "NYLON 210 D" (PY-533);

tongue lining: black three-dimensional fabric "CHA 1350 AIR MESH" (PY-357);

insole: white/blue semi-rigid PP matched with the vamp and quarter lining on the side which is in contact with the foot "CE RIDING INSOLE PP1100N";

removable insock (perforated): grey foam matched with black Lycra on the side which is in contact with the foot, marked "ALPINESTARS" in white on the heel area "LYCRA + EVA HARDNESS 40+/-3 + 2.0 MM HOLES ON THE TOE".

The boot has the following stiff inserts in polymeric material:

- slider insert: orange with logo stitched on the upper;
- ankle and lateral external and internal insert: orange stitched on the upper;
- internal and external ankle insert: black and white disc inserted in the upper.
