fastening system: by means of a lateral zipper positioned on the internal side and a hook and loop flap;

processing: Ago;

sole: black vulcanized rubber provided with a white logo on the forepart area;

<u>upper</u>: declared in black "Microfiber PU A19 1.4-1.5 mm" (M-262) matched with white fabric "36" 0.6 mm CP-C06T/R S" (M-612) and with white print "KTM" and "READY TO RACE":

<u>collar</u>: declared in black "50" 1.0 mm Microfiber Suede" (M-203) sewed onto the main upper;

front joint: declared in black "Microfiber PU A19 1.3 mm" (M-200) matched with white foam material "10 mm Foam DH68-W1 White w/o Adhesive" (M-524) and black coated leather "54" 0.5 mm PU Leather Black B35 + JK/089" (M-212-6);

rear joint: declared in "Microfiber PU A19 1.3 mm" in "FLAME 1655c" orange fluo color (M-200) matched with white foam material "10 mm Foam DH68-W1 White w/o Adhesive" (M-524) and black coated leather "54" 0.5 mm PU Leather Black B35 + JK/089" (M-212-6);

vamp and quarter lining: black three-dimensional air mesh "CY2803 Air Mesh" (M-431); collar lining: black three-dimensional mesh "42" Mesh CY-2803 Black + 3 mm K329 PU Foam Black + 28 g T/C" (M-413-1);

insole: declared in white PP matched with anthracite grey felt-like material;

<u>removable insock perforated</u>: declared in anthracite grey foamed EVA and black Lycra fabric in contact with the foot marked "Alpinestars" in white in the heel zone;

shift-gear protection: black elastomeric material;

<u>slider</u>: polymeric material "DESMOPAN" in "FLAME 1655c" orange fluo c<mark>olor fixed</mark> to the boot by a metallic screw (90 1033 – 9 0842).

The boot has the following stiff inserts in polymeric material stitched on the upper:

- <u>lateral ankle inserts</u>: black TPR, marked "SMX-1 R" in orange color.


